 - Depending on the number of teams, Open and Novice teams might face each other in rounds; teams will be separated by division for awards and final rounds
 - There will be final rounds in all divisions as warranted
 - Team awards will be given to the top 4 teams in each division
 - Speaker awards will be given to the top 5 individual debaters in each division

- Registration will be in the lobby of the Phillips Humanities Building beginning at 3:30 Friday
 - Registration fees:
 - Debate rounds: **\$10** per team per round, plus a \$5 NEDA fee
 - Traditional: **\$65.00** per 2-person team.
 - Crossfire: **\$75.00** per 2-person team
 - There will be a **\$60.00** 'judge fee' for each uncovered team
 - Each judge provided by a school 'covers' two team entries
 - *Cash payments preferred*

Directions:

Exit I-75 at #51 Edwin C. Moses Boulevard. Turn left and follow Edwin C. Moses Boulevard east to Stewart Street. Turn right and continue on Stewart Street to Brown Street. Turn right on Brown and go through two stop lights; the second street after the light is Kiefaber (on the right side of Brown, it's Sawmill). Turn left onto Kiefaber and continue until it dead-ends. You'll see the 'C' parking lot to your left.

Parking:

C lot is open after 4pm on Friday and all day Saturdays, so you won't need any special parking pass. Enter through the driveway by the Visitor Parking Information Hut.
